Experienced Bidders are hereby invited for the construction of the new Waste Disposal Facility, which consists of the construction of a landfill cell with liners and site infrastructure including access road, weighbridge, office building (including ablutions and store room), parking area, portal frame structure with roof, service road, fencing and gates, storm water drainage and contaminated storm water pond, for the BLOUBERG Local Municipality approximately 120 km North of Polokwane.

Only Bidders that have a CIDB contractor grading of **6CE** or higher are eligible to submit Bids. Joint Ventures are also eligible to submit Bids provided every member of the Joint Venture is registered with the CIDB and a combined grade of the Joint Venture calculated in accordance with the construction industry development regulations is equal to or higher than a contractor grading of 6CE.
