Capricorn District Municipality invites proposals from Transaction Advisors representing a team of suitably qualified advisors to help the municipality:

### •Stage 1: Feasibility study

Undertake a feasibility study of the Motumo Trading Post into a tourist destination project in terms of the Municipal Systems Act, Municipal Finance Management Act, the Municipal PPP Regulations and the *Municipal Service Delivery and PPP Guidelines*.

### •Stage 2: Procurement
