**6. FIRE AND RESCUE SERVICES**

**6.1. CAPRICORN DISTRICT MUNICIPALITY EMERGENCY SERVICES BY-LAWS FINES AND PENALTIES, PART IX PENALTIES SECTION 48.**

6.1.1. Penalties for contraventions

Any person who contravenes or fails to comply with any provisions of these By-laws, including any condition or requirement for a certificate of registration or spraying permit, or any instruction by a member of the Service, is guilty of an offence and on conviction liable to a fine not exceeding R5 000 or in default of payment, liable, on conviction, to imprisonment for a period not exceeding six months.

**10.4. FINES AND IMPRISONMENT IN LINE WITH SECTION 18 OF THE FOODSTUFFS, COSMETICS AND DISINFECTANTS AMENDMENT ACT 39 OF 2007.**

- 10.4.1. SEC 18 OF THE ACT: (a) on a first conviction, to a fine of **R2000** or to imprisonment for a period not exceeding **six months** or to both such a fine and such imprisonment;
- 10.4.2. SEC 18 OF THE ACT: (b) on a second conviction, to a fine of **R4000** or to imprisonment for a period not exceeding **twelve months** or to both such a fine and such imprisonment.
- 10.4.3. SEC 18 OF THE ACT: (c) on a third or subsequent conviction, to a fine of **R8000** or to imprisonment for a period not exceeding **twenty-four months** or to both such a fine and such imprisonment.

**10.5. INCLUSION OF THE VALIDITY PERIOD ON THE CERTIFICATE OF ACCEPTABILITY (COA) IS TWELVE (12) MONTHS FROM THE DATE OF ISSUE**

COA is a certificate that is issued to a food handler when complying with Regulations governing general hygiene requirements for food premises, the transport of food and related matters. R638 of 22 June 2018 read with section 18 of the Foodstuffs, Cosmetics and Disinfectants amendment act 39 of 2007 as amended. This is an indication that food prepared in such an area is safe for human consumption.
